Maria asked if we had heard about the 2017 budget process. Ned was told it will begin in December. Maria stressed that we need to be prepared going into these discussions so that we are not impacted in the same we were last year. We need to be proactive.

It was determined that we will get dates for a possible day trip to the Yonkers library to visit their MakerSpace. It was determined that daytime was better in that select staff could attend.

### **New Business:**

We received a letter from NYLA requesting that we contribute funds to their legal defense fund in the aftermath of a challenge to Education Law 259(1)(a). Ned was told that by a legal expert on libraries that we cannot and should not make such a contribution. Personal donation and/or support from the Friends is possible. We will share with the Friends at our joint November meeting.

In the mayor's recent newsletter thanked the rec department for keeping programs up-and-running while the Embassy Center is closed but made no mention of the library, which is hosting many of the programs. Betty wrote a letter to the mayor in complaint. She will forward that letter to the group and ask that Larry Taylor to discuss specifically with the mayor, as he is our Village liaison.
